1. INTRODUCTION

The purpose of this report is to document annual audit conformance of **Louisiana Forestry Association (LFA)**, hereafter referred to as SmartLogging Operation (SLO). The report presents the findings of PREFERRED BY NATURE auditors who have evaluated company systems and performance against the SmartLogging standards and policies. Section 2 of this report provides the audit conclusions and any necessary follow-up actions by the SLO through corrective action requests.

3.1. Auditors and qualifications:

Member of the Society of American Foresters and a Certified Forester (#1547), and a WV Registered Professional Forester (#266). Completed FSC COC Lead Auditor training Aug. 2018, and FM Lead Auditor training in May 2018. Completed 30 Chain of Custody audits (2 of which were Controlled Wood), 42 Forest Management audits (28 as lead auditor, 8 reassessments/4 as lead), 4 SAP (Smallholders Access Program) audits, and 5 Smart Logging audits.
